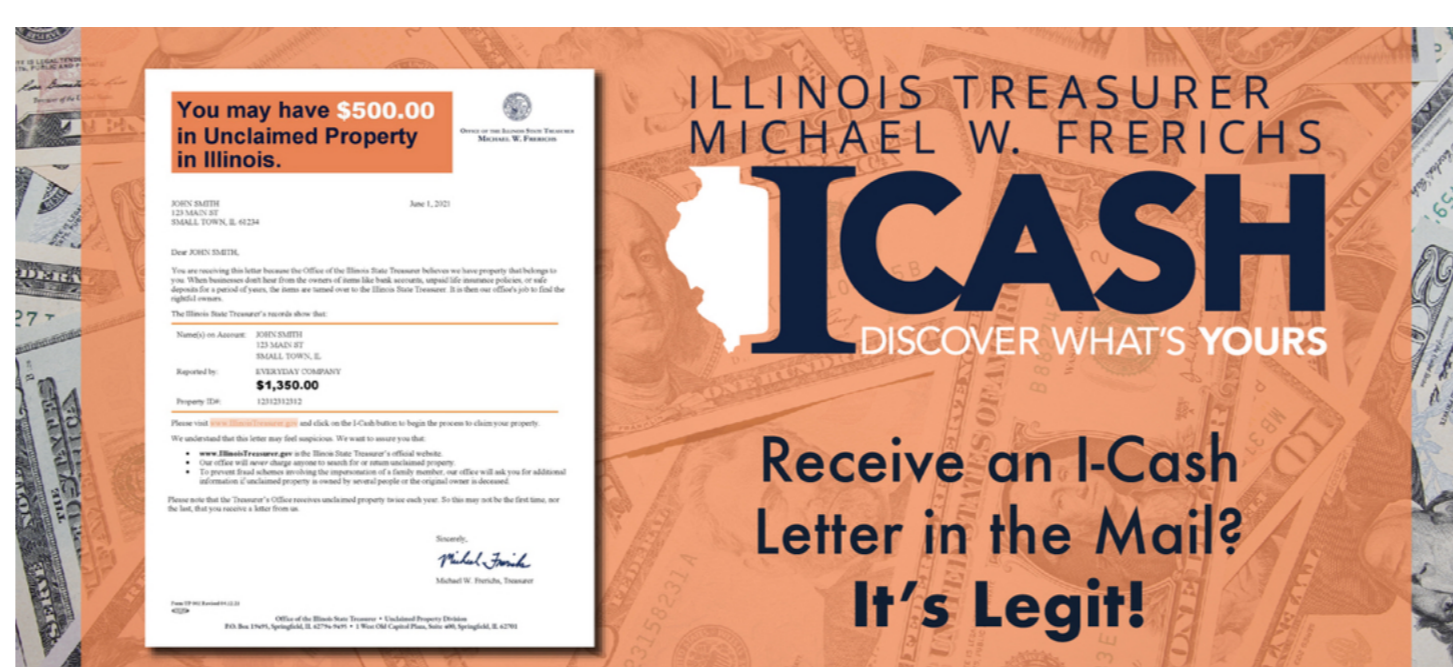

## Disability Pride Month

### IL ABLE

#### Disability Pride Month

Thirty-two years ago, Congress passed the Americans with Disabilities Act, also known as ADA. This landmark civil rights law prohibits discrimination against individuals with disabilities in all areas of public life. We celebrate Disability Pride Month each July to honor the diversity and achievements of people with disabilities.

There is much to celebrate. Today, people with disabilities have greater access to fully participate in their communities including schools, jobs, transportation, parks and theaters.

One of the promises of ADA was to ensure economic self-sufficiency. Critical to this is being able to save and control your own money. The Achieving a Better Life Experience – ABE – took a critical step in helping to achieve self-sufficiency by saving money without jeopardizing federal means-tested benefits.

However, more needs to be done.

When Congress enacted ABE in 2014, it included a threshold of 26 years of age. That means the disability must manifest itself by a person's 26th birthday. This arbitrary number needs to be raised so more people with disabilities – especially veterans – can empower themselves to save their own money and pursue their dreams.

#### Did You Know?

Illinois Secure Choice is a state-facilitated retirement program that makes it easy to save for retirement. Since it launched in 2018, the program has brought retirement savings access to workers in every county across Illinois. Not only is Illinois Secure Choice open to employees who work for an eligible employer, the program is available to anyone who wants to enroll on their own and start saving, including the self-employed. Beginning in 2023, the program will cover all employers with five or more employees. Small businesses can register now and do not have to wait for their deadline. More information is [here](#).
