MINUTES

1) Call to Order

Treasurer Frerichs called the meeting to order at 3:00PM.

Alex Armour took roll.

A quorum was present.

2) Welcome and Introductions

Treasurer Michael Frerichs welcomed all board members and shared the positive experiences he has had meeting the various awardees and seeing first-hand the impact the Charitable Trust grants are making in communities across Illinois.

3) Approval of Minutes from June 6, 2019

Meeting minutes from June were approved.

4) Charitable Trust Program Update

Alex Armour gave an overview of the various events and accomplishments around the grants made via the Charitable Trust Program. To date, 100 grants have been awarded to non-profit organizations in over 60 municipalities.

Charitable Trust is now accepting applications for its 6th grant cycle. Currently there are three applications which have been completed and 86 are in progress.

The application period for the 6th grant cycle will close on Sept 30.

5) Charitable Trust Budget Update for FY 2019

Alex Armour provided a summary of the FY 2019 Budget and gave an historical

overview of fund revenues versus spending. In FY 19, 74% of the budget went towards grant payments. By statute, only 50% of the fund balance may be spent on grants to ensure the sustainability of the program.

6) Depressed Area Scoring Discussion

Alex Armour addressed previous concerns on whether the additional five points given to organizations in depressed areas made a significant difference on their final score.

The number of awardee organizations which would not have been awarded a grant without the additional five points was insignificant.

7) Application Changes

There was no discussion.

8) Committee Member Training

Gwendolyn Drake reminded everyone that all board members are required to complete Ethics and Sexual Harassment Prevention Training annually. If board members have taken this training with other organizations, an attestation form must be signed and submitted.

New board members are also required to complete Open Meetings Act training by the end of the year.
